



The undersigned is directed to refer to Department of Personnel and Training (DoP&T)'s O.M. No. 11013/10/2013-Estt.A dated 09.01.2014, on the subject mentioned above.

2. In compliance of the Hon'ble Supreme Court's Order dated 31.10.2013 in W.P. (Civil) No. 82/2011, it has been decided to constitute a Committee for recommending posting/transfer in each grade of Indian Trade Service (ITS) and other officers in the Directorate General of Foreign Trade (DGFT), as indicated below:-

**\*\* As the transfers/postings in respect of FTDOs are decided in DGFT Headquarters, the Committee mentioned at Sl. No. 2 above will decide the transfers/postings of FTDOs both within the Zones as well as outside the Zones.**

3. The Committee would take up the following while recommending to the Competent Authority:-

- a) Section Heads and Foreign Trade Development Officers are liable for transfer within the Zones. ITS officers are liable for transfer all over India. At the time of transfer, officers may indicate options for choice of postings and transfers would be made subject to exigencies of work.
- b) **Normal Tenure:** Normally ITS officers will be allowed a minimum tenure of 3 years in a post.
- c) **On Promotion:** Officers will be transferred on promotion, irrespective of the number of years spent at the place of posting, except in cases where the officer is retiring within a period of 2 years.
- d) **Tenure of Deputation:** As per approved guidelines, the maximum period of service of an ITS officer to an ex-cadre/foreign service/cadre post outside DGFT will be 5 years and on completion of 5 years tenure, the officer will revert to his parent organization, i.e. DGFT and serve for 2 years as cooling off period in the Zonal Offices/Regional Authorities of DGFT. The period of deputation/posting outside DGFT beyond 5 years can be extended only in exceptional circumstances with the specific approval of the Hon'ble Commerce and Industry Minister. Extension beyond 7 years will not be permitted.

- e) Request for transfer posting on exigencies can be considered on file with the approval of the Competent Authority.
- f) An officer who has less than 2 years of service left prior to superannuation will not normally be transferred unless there are compelling circumstances.
- g) Postings of spouse in the same station can be considered and also providing station of their choice to officers on return from postings in harsh areas like Srinagar, North-East. etc. would be considered as far as possible.
4. The transfer policy and guidelines prescribing the tenure for posting of ITS and other officers in DGFT are only directory in nature and not mandatory. Any officer can be transferred by the Competent Authority at any time to any post on administrative grounds.
