The details submitted by Wool Industry Export Promotion Council with regard to wool blended yarn containing wool & nylon (dyed) and wool blended yarn containing wool & nylon (grey) were gone through. The Committee observed that council has not given the average details of both the items separately so that basis of calculation can be worked out for re-fixation of DEPB rate. In view of this Committee decided to call for the same data from Wool Industry Export Promotion Council and defer the case for re-listing on 08.10.2009.
