Textiles Products (J- Group): J- 92, J- 96, J-99, J-100, J-101 & J-308.

Leather Products (G- Group):- G-1 and G-39.

Thus, Committee observed that in the Textiles & Leather Product Groups, the SIONs do not contain fuel as consumable to be used in the production process directly. Therefore various fuels are allowed only for captive power generation and not as consumables under Textiles & Leather Product Groups. Accordingly, PC-4(B) Section may be informed.
