The Committee felt that if import item is degummed then 5% wastage is adequate but if import item is in gummed form then only 35% wastage is justified. Hence, 35% wastage can be allowed only when import item is in gummed form. Accordingly, Committee decided that description of import item may be amended to read as "Thrown Silk Yarn (Mulberry Raw Silk Twisted Yarn (in gummed form))" in partial modification of its earlier decision.

Hence, the Committee decided to maintain status quo in this case.
