

### **Type of Trade Data available on different sources**

During the Port Officers Meeting, it was discussed that 'Information Dissemination Booklets' need to be designed to awareness outreach to exporters under Niryat Bandhu Scheme. Accordingly the 8 themes on which Booklets need to be designed were allocated to the RAs. In this regard, the theme 'Trade Data' was assigned to Statistics Division, DGFT. The details of available 'trade data – export and import' are as follows:

1. Following commodity-wise and country-wise export/import data in terms of quantity and value, month and year wise, is available on Department of Commerce website and can be accessed through the link: <https://tradedstat.commerce.gov.in/eidb/default.asp>.

The Monitoring Dashboard hosted on Department of Commerce website (<https://dashboard.commerce.gov.in/commercedashboard.aspx>) provides month-wise and year-wise import, export and balance of trade data for all items at principal commodity group and at 2-digit, 4-digit, 6-digit and 8-digit ITC-HS code level in value terms for different countries and territories. The dashboard also provides import and export data of product-category wise like raw material, capital goods, consumer goods and intermediate goods for different countries at principal commodity level. - (J) An annual as well as Monthly Management Information System (MIS) Report on Export Promotion Schemes has been brought out since 2017 for effective monitoring the

performance of Regional Authorities in general and evaluation of the Foreign Trade Policy (FTP). The report provides year wise All India, Zonal-wise, RA wise issuance of authorisations/ scripts under various export incentive schemes (MEIS, SEIS, FMS, etc), authorizations issued, export obligation (EO) fulfilled and its pendency under Advance Authorization and EPCG schemes. ### **(3) Directorate General of Commercial Intelligence and Statistics (DGCI&S):**

As per Data Dissemination policy, transaction level data (Shipping Bill/ Bill of Entry wise, Shipment/Consignment/Invoice wise, Daily Date wise) is not disseminated by DGCI&S. The following type of data that is disseminated by DGCI&S is at aggregated level:

- (i) Commodity wise (2/4/6/8 digit HS level and Principal Commodity wise)
- (ii) Country wise
- (iii) Port wise
- (iv) 'Commodity x Country' or 'Country x Commodity' wise
- (v) 'Commodity x Port' or 'Port x Commodity' wise
- (vi) 'Country x Port' or 'Port x Country' wise
- (vii) 'Commodity x Country x Port' or 'Country x Commodity x Port' wise
- (viii) 'Export by State of Origin'
- (ix) Export by District of Origin

DGCI&S disseminates above data through a dedicated foreign trade data dissemination portal available on DGCIS's website [www.dgciskol.gov.in](http://www.dgciskol.gov.in), where three types of user login are available:

- 1) Official – for accessing data free of charge
  - 2) Guest
  - 3) Subscriber
- } – for accessing data on payment basis.

The Trade data is disseminated free of cost only to Government Ministries/Department, the Reserve Bank of India, Indian Embassies abroad and United Nations Bodies according to their specific requirements. Principal commodity level data for the past 24 months are also disseminated free of cost to private users through the foreign trade data dissemination portal. No request for free supply of data is entertained in case of Private Bodies or other agencies not specified above. All private users are required to make payment for their specific data requirements. The applicable charges for procuring data is Rs. 1.00 for each record/row of data. Subscription charges for Annual Bulk Data (All Commodities x All Countries x All Ports) (Month-wise data):

(i) For Indian users: INR 350,000/- per year for current year,

(ii) For Foreign users: USD 7500.00 per year

**Discounted Data Cost:**

The facility of Institutional Subscription is based on IP address recognition allowing individual members of Institution/Organization to have automatic access with full functionalities including download of data. Indian Academic/Research Institutions or Libraries opting for such IP address recognition based subscription will be offered a discount of 60% to the annual bulk data cost, provided a written undertaking stating that the data obtained shall be used only for non-commercial purpose, is submitted to the Director General, DGCIS and the same is approved in advance.
