ORDER-IN-ORIGINAL

1. Any party or person/s aggrieved by this Order may file an appeal against the same to Additional Director General of Foreign Trade, 6<sup>th</sup> Floor, ReshamBhavan, Laldarwaja, Surat in terms of Section 15 of the Foreign Trade (Development and Regulation) Act, 1992, within 45 days from the date of issue of this Order under intimation to this office.
2. The penalty amount shall be deposited within 45 days from issuance of this Order under intimation to this office under the Head of Account '1453 – Foreign Trade Export Promotion, Minor Head – 104 other receipts, fines and penalties etc. –Import and Exports Control Organization'. Penalty amount can also be submitted to online [dgft.gov.in](http://dgft.gov.in) > Service > Online Ecom Application >eMPS.
3. If penalty is not paid, it shall be recovered as an arrear of land revenue of the person concerned and IEC may be cancelled as per Section 8 & 11(4) of FT(D&R) Act.

FACTS OF THE CASE

4. M/s.Alpha Packaging Ltd(IEC: 3494001987, PAN:AACCA0053A), thenoticee, having address at 401 Accron Building Joggers Park, Road Behind GhodDod Road Surat,Gujarat Pin-395007and its Proprietor/ partners/directorsapplied and obtained license for Export Promotional Capital Goods Schemeunder Chapter 5 of Foreign Trade Policy vide file number 52/21/021/00456/AM07 on 03.11.2006 and with following details:

5. As per condition sheet attached and conditions imposed under the scheme, the applicant is bound to fulfill Export Obligation of USD 59,227.75ie8 times of duty saved of capital goods on FOB basis with a period of 8 years from the date of issue of authorization.
6. The noticee submitted Bank Guarantee against Invalidation. Bank Guarantee is issued by Oriental Bank of Commerce, Jash Market, Ring Road, Surat with Guarantee no 01020006106 dated 10.11.06 of Rs. 2,65,000/- . Then bank also agreed not to revoke BG without prior consent from us.
7. Export Obligation period ends on 02.11.2014.
8. After expiry of period no export obligation fulfillment documents are submitted which are required under Foreign Trade Policy.
9. Demand Notice was issued with facility of Personal Hearing on 31.10.18.
10. Refusal Order Notice was issued on 24.07.19.
11. Show Cause Notice with facility of Personal Hearing was issued on 06.12.19.
12. Final call for Personal Hearing is issued on 06.12.19.

**FINDINGS**

13. A Show Cause Notice issued gave 15 days reply time with facility of personal hearing to the notice. But no Personal Hearing was attended by the notice and no reply was submitted till date. So natural justice was done with enough opportunities.
14. In my opinion, the notice while signing any documents must be aware of result of misuse. The noticee must not make any fraudulent documents and declaration which are contrary to the facts knowingly or unknowingly. To promote exports, the government waived off Duty of Rs337228/- to the noticee. This duty is hard earned money of the government which was appropriated from honest tax payers of the country. The notice misappropriated and misused money of the government and did fraud to the government by taking undue benefit from government exchequer. So the noticee is fully responsible and mastermind for this modus operandi of fraud. The noticee has also not fulfilled export obligation till date. Because of this, the government lost Rs337228/- with addition of interest calculated from date of issuance of the license. So I found that the noticee violated Section 9 and 11 of Foreign Trade (Development and Regulation) Act, 1992. 'Person' under Section 11 of Foreign Trade (Development and Regulation) Act, means natural and legal person. In this case the proprietor/partners/directors in the name of his company is/are found guilty of violation of the Section 11 and liable to be imposed penalty.

**ORDER**

15. I therefore in exercise of powers vested in me under Section 9, 11 & 13 of the Foreign Trade (Development & Regulation) Act, 1992, hereby impose fiscal penalty as below:
