

Corrigendum to the Minutes of the Meeting No.07 (2023-24) and 08 (2023-24) of Export Facilitation Committee (EFC) held on 24.11.2023 and 22.12.2023 respectively.

As per approval of EFC chairman, a decision was taken not to allow further export authorizations for export of Raw Human Hair to the applicants who have been allotted export quantity in FY-2023-24 more than equal to the quantity issued first time after imposing restriction. Accordingly, those who have already been granted export authorizations for FY 2023-24 were rejected to not allow further authorization for the same FY.

2. Further, a number of exporters have requested that their livelihood is at stake. Considering the difficulties brought to notice by the exporters, it has been decided to reconsider the matter.

3. Accordingly, the following 17 rejected applications were reconsidered and issued export authorization.
