**ADVERTISEMENT FOR EMPANELMENT OF TECHNICAL EXPERT IN
DIRECTORATE GENERAL OF FOREIGN TRADE, DGFT, NEW DELHI.**

The Directorate General of Foreign Trade (DGFT) formulates, implements and monitors the Foreign Trade Policy (FTP) which provides the basic framework of policy and strategy to be followed for promoting exports and trade. The Trade Policy is periodically reviewed to incorporate change necessary to take care of emerging economic scenarios both in the domestic and international economy. Besides, the Directorate is also entrusted with responsibilities relating to multilateral and bilateral commercial relations, special Economic Zones, state trading, export promotion and trade facilitation, and development and regulation of certain export oriented industries and commodities.

2. The Direct General of Foreign Trade (DGFT) also publishes the Standard Input Output Norms (SION) to specify the required amount of inputs needed to produce a unit of outputs for exporting. SION is applicable for numerous products, including electronics, engineering, chemical, handicraft, plastic, leather, and many more; it is also suitable for various food products such as fish and other marine products. Advance licenses are issued based on the inputs and export items given under SION, and the applicant's exporter needs to ensure that the goods sought for import and import are used in the export product. The manufacturer, exporter, and merchant-exporter can modify these norms by applying DGFT.

3. The Directorate proposes to empanelment of 72 Technical Experts in Directorate General of Foreign Trade, DGFT, New Delhi during the year 2023.
