The committee also noted that most of the firms while submitting the advance license application for the above category of product have been claiming 5% wastage for making export item "Nonwoven fabrics made of manmade fibre" from import item of "Poly propylene Granules". They are claiming average wastage of 5% even from Granules / Chips, a source material for relevant fibres. After detailed deliberation, the committee decided to visit the manufacturing unit to understand the wastage claimed to manufacture the export product.
