The Committee considered the case as per agenda along with other relevant papers and noted that the firm has provided details of export items exported under various shipping bills. The export items are exported under the relevant HS codes by maintaining constituents and blend ratio of inputs in accordance to the HS code but some products exported have different fibre constituents than as applied in advance authorization application. The firm has sought higher wastage for manufacturing of fabrics and the wastage is restricted to the relevant/similar existing SIONs. The qty of export is also endorsed by the Customs office on the basis of shipping bills with number and date. Based on recommendation of technical authority, on the basis of information provided by the firm for manufacturing process and taking cue from relevant/similar existing SIONs(J-39,124,129,132) the quantity of inputs are recommended as under:

<p>The Committee considered the case as per agenda along with other relevant papers and noted that firm has submitted their request for fixation of norms vide dated 24.03.2022 as their case was rejected in NC meeting no 9/84-ALC3/2019 dated 29.08.2019 and 04/AM22 Dated: 27/10/2021 due to non submission of requisite information. Now the firm has provided details of export items exported under various shipping bills i.e. no.9165502, dt 9.10.17, 9125297 dated 6.10.17, 9181642 dated 9.10.17, 9161172 dated 9.10.17, 9179458 dated 9.10.17, 9201303 dated 10.10.17, 9197689 dated 10.10.17, 2501043 dated 29.01.18, 2361037 dated 22.01.18 etc. As per manufacturing process, the cotton yarn is converted into cotton woven fabrics of different GSM. The 10% wastage is considered for weaving of cloth from cotton yarn and 5% wastage on manufacturing of end products from woven fabric on the basis of SION J-92 and J-109 respectively. The finishing chemicals are used in less than 1% ratio except sizing material and Dyes. The sizing material and dyes are restricted by taking cue from existing relevant SIONs.</p> <p>Based on recommendation of technical authority, basis of information provided by the firm for manufacturing process and taking cue from relevant/similar existing SIONs(J-92 and J-109) the quantity of inputs are recommended as under:</p>
