Mtrs as UOM. The recommended qty of inputs was given in Kg due to nature of fabric as Knitted Fabric. Since the knitted fabric imported in this Authorization(0510415451dated 09.10.2020) is made in fine gauge, therefore based on recommendation of technical authority, committee decided to amend the UOM of recommended qty. of import items to Sq. Mtr. as under:
