

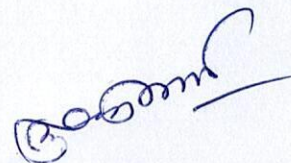
Minutes of Meeting of Exim Facilitation Committee (EFC) meeting No. 05/AM25 dated 27.08.2024
