The Committee did not find any scope to review the Qty. of inputs allowed in this case. Hence, decided to maintain status quo. Thus, request of the firm cannot be acceded to, hence rejected.

RLA may take suitable consequential action accordingly. They may also be advised to furnish compliance report whether style No. imposed on the export side in earlier decision of NC has been complied.
