Decision: The Committee considered the case as per agenda alongwith other relevant papers and observed that in this case TC, Mumbai had directed their regional office at Noida to conduct on the spot study of the unit of the firm and submit their report. But, so far no report has been received either from TC, Mumbai or from their regional office at Noida in the matter. The Committee after deliberations in consultation with the representatives of technical authorities present in the meeting felt that in this case since applicant firm is preparing for the export of made-ups of various motifs/designs for which 5% wastage is adequate. In view of this Committee decided to ratify the A/A issued in this case by allowing 5% wastage as detailed below:-

Decision: The Committee considered the case as per agenda and observed that this case has already been cleared by ALC in its meeting held on 24.06.2004 by imposing certain Style No. But, the firm have mentioned that they have already made export shipments under the A/A in question during 2004 whereas the ALC decided this on 24.06.2004 and as such in the export documents they could not endorse the Style No. In view of this Committee in consultation with the representatives of technical authorities present in the meeting decided that in this case the condition of Style No. may be monitored only in respect of exports made after the communication of ALC decision. Prior to ALC decision, the condition of Style No. may not be insisted upon. In future, applicant firm have to invariably mention specific style no. of their export product

Decision: The Committee considered the case as per agenda alongwith relevant information/documents submitted by the firm and observed that out of four items of import mentioned against the A/A in question, applicant firm have sourced the item of import at S.No. 1 i.e Polyester viscose blended grey fabric, S.No. 3 i.e Disperse dyes and S.No. 4 i.e Binder from domestic market and they have imported the import item at S.No. 2 i.e Nylon Tow only against A/A in question and hence requested for deletion of import item No. 1, 3 & 4. The Committee after detailed deliberations in consultation with the representatives of technical authorities present in the meeting decided to ratify the Advance authorization issued in this case by allowing Nylon Tow with 5% wastage and by deleting remaining items of import as detailed below:-
