Neelam Negi, an authorised representative of the firm, who appeared for personal hearing before Committee. She explained all the three export items alongwith sample. The Committee observed that these items are manufactured by using various circles (6-7) of flowers (82) in order to meet the buyers' order. It was felt that use of these flowers justify the higher consumption of fabrics in this case. Therefore Committee after deliberations in consultation with representatives of technical authorities present in the meeting observed that quantitative requirement of fabric asked for in this case is adequate. Thus, Committee decided to ratify the Advance Authorization issued in this case as detailed below:-

Decision: The Committee considered the case as per agenda alongwith other relevant papers and observed that from the description of the export item, it is not clear that what is the material used for Gloves. They have given overall requirement of Nomex fabric in different colours whereas in the application they have mentioned 100% knitted Nomex fabrics in different Qty. Accordingly, it was felt that without knowing that where each type of fabric is used in each item or not, it is not possible to compute the requirement of each inputs against the respective export item. Further, quantitative requirement of lining indicated therein is higher than that of shell fabric, which is also not justified. They have also not submitted Process Flow chart in this case. In view of the above facts Committee was unable to compute the requirement of inputs. Therefore, Committee was constrained to reject the case.
