The description of export item given as "Grey/dyed/printed fabrics with embroidery made out of 100% Natural Silk fabrics, GSM-54, width-44" undyed and unprinted" whereas in SION J-51, the description of export product given as "Grey/Dyed/Printed Fabrics with Embroidery".

It is observed that the description of export product given in SION J-51 does not match with one to one description of export product given by the applicant firm, as Silk products does not get covered under SION J-51. The Silk products covered

under SION J-123, J-124, J-125, J-129 & J-132. Moreover, applicant firm has not made available the shipping bills of the export products in support of their proposal. The Committee agreed with the decision of the RA that the export product does not covered under SION J-51.
