(TEXTILES AND LEATHER ITEMS)

At the outset the Minutes of NC Meeting No. 33/AM09 dated 13.11.2008 and NC Meeting No. 34/AM09 dated 20.11.2008 were ratified. However, the following amendment was made in the Minutes of NC meeting No. 30/09 dated 23.10.2008 as under: -
